2023 Program in Review



EXECUTIVE SUMMARY



In January 2023, Tampa Bay Wave, kicked off the 2023 cohort for its **CyberTech|X Accelerator**. In its third year, the CyberTech|X Accelerator was created for the purpose of furthering **Tampa Bay's reputation as a nationally-recognized hub for cybersecurity talent and innovation** and brings together key partners for this regional innovation cluster.

We are proud to say that the 2023 cohort was another incredible success with 15 cybersecurity startups recruited from across the US and beyond! Thanks to our **Florida-Israel Business Accelerator (FIBA)** partnership, the cohort included another strong Israeli startup as well as companies from Mexico, Australia (whose founder flew back-and-forth 30 hours six times to participate) and Switzerland (whose founder spent his own money to live in Tampa for 4 months to participate specifically because he valued the quality of Wave's programming and sponsors).

As a nonprofit 501(c)(3), Wave takes zero equity from the participating companies. Thus, the CyberTech|X Accelerator is 100% funded by the generous support of sponsors and donors. Key funding of this program was provided by **A-LIGN, KnowBe4 and EY**; plus strategic partners: **Cyber Florida, Bank of America, and USF Muma College of Business**.

The 15 startups selected for the 2023 cohort participated in a 90-day intensive program that included dedicated mentors, one-on-one coaching with notable tech founders, sales training, pitch coaching and investor introductions in an environment designed to support high-scale growth. Beyond the 90-day program, the participating companies are now enjoying ongoing support through Tampa Bay Wave's virtual and live CORE membership to further accelerate company development.

As of this report, collectively, well **over 500 hours** of mentoring and other support have been provided to these companies, as well as invaluable exposure opportunities through press, social media and Wave's signature events that showcased this year's cohort of companies.

We are grateful to our sponsors and partners who made our 2023 **CyberTech|X Accelerator** an incredible success again for year three which has helped to strengthen Tampa Bay's growing reputation for cybersecurity and technology. Stay tuned for our plans for a year-four cohort!!

The 2023 CyberTech|X Accelerator program enjoyed nearly a full-year of recruiting. The importance of **year-round recruiting** cannot be understated because as the accelerator industry knows... the startups choose the program, and not the other way around.

The 2023 CyberTech|X cohort has several serial entrepreneurs, many boasting prior exits. Combined, the group has **over 100 years of cybersecurity experience**, some engaged since the dawn of the industry. They have also **collectively raised over \$30 million dollars** prior to entering the program.

This cohort featured four (4) international startups, but even more applied. Utilizing international partnerships, particularly with FIBA (Florida Israel Business Accelerator), Wave is able to extend its reach and establish Central Florida as a valuable emerging tech space.

Economic Development

Programs like CyberTech|X shine a light on Tampa and the Tampa Bay region as an innovation hub, and gives Wave the opportunity to showcase the area to startups as a desirable destination for expansion or relocation. Each Accelerator represents nearly 300 hotel room nights and 150+ flights through Tampa airport plus other travel expenditures covered by the founders, fueling the local economy.

Geographic Diversity

In 2023, **83%** of the applications came from outside of Florida, and **41%** came from outside the U.S.

Of the final 15 companies selected, **14** were from outside Florida and **4** were from outside the U.S.

\$900K Pre-seed round PLUS multiple SBIR contracts underway

Redactable, a New York-based AI-driven solution for automated and secure redaction of digital documents, was part of our 2022 CyberTechIX cohort. CEO Amanda Levay was inspired to create Redactable after having personally witnessed the inefficiencies in the space in a prior role. Redactable was able to raise a significant part of their Seed round, just under one million dollars, in a matter of months and closed during the cohort. Following the cohort, the company has been able to secure multiple SBIR contracts with the U.S. Air Force, indicating that her solution will perform at even the highest levels of security.

Amanda has become a great resource for the 2023 cohort, having come back to Wave as both a speaker and mentor, guiding future classes with her experience and perspective.

From cohort participant to exited founder – in less than a year!

Founder Felix Brombacher came to Tampa Bay Wave in January 2022 as part of the 2022 CyberTech|X Accelerator. Based out of Munich, Germany, Crashtest Security is a developer-oriented dynamic application security testing (DAST) cybersecurity product. A multiple-time founder, Felix was experienced in building a startup but needed help with expanding into the U.S. market. Building upon successes with several large clients in Europe, the company was able to gain traction in the U.S. over the next few months. Wave was able to help the team understand how to penetrate U.S. enterprises, make key connections, and further expand the vision. In **December 2022, Crashtest Security was acquired by Veracode**, a Boston-based, leading global provider of modern security testing solutions. Crashtest became the **third CyberTech|X alumni to exit** within the three years of the program.

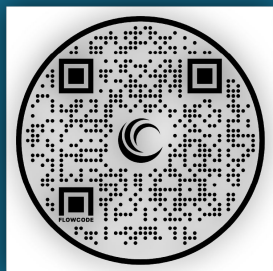
