

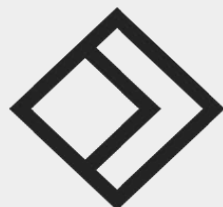

EXECUTIVE SUMMARY

Tampa Bay Wave's 2026 **CyberTech|X Accelerator** reflects our sixth year hosting this program that we launched in 2021, thanks to the unwavering support of A-LIGN as our inaugural supporter. This accelerator continues to blend Wave's world-class resources from our nationally-recognized programs with industry-specific expertise and strategic connections to support the growth of the cyber technology sector for the Tampa Bay region and beyond.

Fifteen (15) exceptional startups were selected for this cohort. Collectively they have already raised nearly \$55M in funding and are generating over \$6.5M in annual revenue. Their innovative technologies are addressing: data security, vendor risk management, fraud prevention, supply chain risk reduction, encryption and tracing tools, threat exposure identification plus social engineering and malicious content attacks protection, among others.

The 2026 CyberTech|X Accelerator was made possible, thanks to the continued support of A-LIGN, along with contributions from Potomac Law Group and Thoropass, plus our newest supporter Get Dynasty. The program provided these emerging technology companies with a broad spectrum of industry expertise, strategic connections, mentorship, and access to private investment capital.

Collectively, well over 100 hours of mentoring and other support were provided to this year's cohort companies from Wave's Mentor Network as well as our CyberTech|X Advisory Council, a carefully chosen group of sector-specific advisors in the cybersecurity, financial, data management, risk, compliance and governance sectors.

The 2026 CyberTech|X Accelerator was another resounding success! We are also proud to announce that one of these cohort companies, SafeHill, have now made plans to relocate from Chicago to the Tampa Bay region after being impressed by our region's cyber technology community and welcoming business environment.

Wave is grateful to all those who contributed to this successful cohort, and thus support our mission to build a stronger, more-resilient innovation-driven economy in the Tampa Bay region, in Florida and across the U.S. The follow pages outline some of the highlights from this year's program.

ThreatMate, co-founded by CEO Anup Ghosh and based in Tampa, joined the 2026 CyberTech|X Accelerator to scale its AI-powered attack surface management platform designed to bring enterprise-grade cybersecurity to small and mid-sized businesses through Managed Service Providers.

During the program, ThreatMate leveraged its \$3.2 million seed round – raised prior to joining the cohort and led by Top Down Ventures, Runtime Ventures, and Blu Ventures – to accelerate product development and deepen integrations across the MSP ecosystem, building on Ghosh's track record of cybersecurity exits exceeding nine figures.

SafeHill, co-founded by CEO Mike Pena, joined the 2026 CyberTech|X Accelerator to advance SafeHill SecureIQ™, its Continuous Threat Exposure Management platform that combines AI-driven automated penetration testing with expert human validation to help enterprises expose attack paths before hackers can exploit them.

During the program, SafeHill built on its \$2.6 million pre-seed round led by Mucker Capital and Chingona Ventures to expand its enterprise customer base and deepen its roots in the Tampa Bay region, with the company announcing its relocation to Tampa in late April.

Mentor & Investor Networks

Advisory Council + Mentor Network

Participating companies tapped into a network of 260+ volunteer mentors passionate about supporting early-stage startups. Some offer expertise in areas like HR, go-to-market strategies, or trademark law, while others provide ongoing CEO coaching. Various programming is designed to facilitate mentor introductions and relationship building between the startups and mentors. On average each participating startup gained 20–30 direct connections and received 100+ hours of hands-on guidance.



Investor Network & Demo Day

Startups in the 2026 CyberTech|X Accelerator tapped into Tampa Bay Wave's national network of 600+ investors through a high-touch, curated matching process. Rather than blanket outreach, Wave's investor team reviewed each investor's thesis and made targeted introductions based on fit, an approach made possible by the cohort's focused size of six companies.

Wave continues to expand its investor reach in key markets like NYC, Austin, and San Francisco while providing hands-on support with investor readiness and non-dilutive funding through SBIR/STTR programs. With portfolio companies surpassing \$1.7B raised, Wave ranks among the top five nonprofit startup accelerators nationwide.

Wave's Mentor Network

Wave member companies have access to a wide network of professionals in our 260+ all volunteer Mentor network. These professionals have a passion for helping early stage startups. Some offer their expertise on specific topics (such as HR or trademark laws), while others may coach a startup on an ongoing basis, depending on what support the founder(s) need. We host regular Mentor mixers to build strong trusted relationships. Startups receive at least 20-30 direct mentor connections during their time in the program resulting in easily 100+ hours of consulting help.

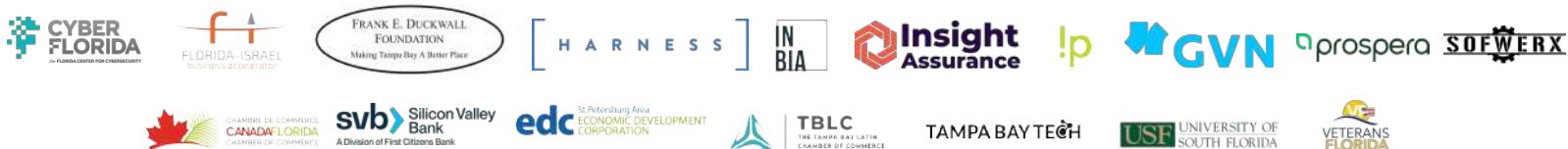

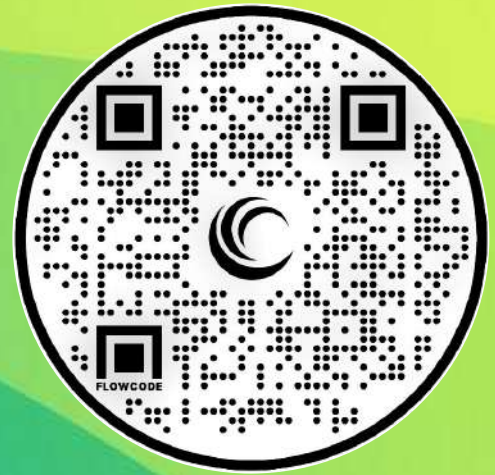
